National Meteorological Congress

June 6 and 7, Montreal

The Congress will comprise three sessions at the University of Montreal and one session, held jointly with the Royal Society of Canada, Section III, at McGill. The programme for this joint meeting (7th June, morning) will consist of five papers on the physics of precipitation, of which three will be devoted to hail. Another session will deal with the stratosphere. The topics for the remaining sessions have not been determined, but papers will be offered on numerical models, climatology and pollution. There is still room in all fields for some additional contributions, and I would welcome receiving titles and brief abstracts without delay.

As a novel feature in Canada, some of the papers will be fairly formal presentations of work recently published in the Quarterly Journal, and the discussion on them will be appearing in that Journal in a subsequent issue. The majority of the papers will be briefer contributions on work that has not yet quite reached the stage of formal publication.

Minutes of the 20th Annual Business Meeting

The meeting was called to order by the President, Prof. J.S. Marshall, at 8:00 P.M. on Tuesday, April 19, 1960. The locale was the Faculty Club, McGill University, Montreal.

The minutes of the previous annual meeting, held in Toronto, were available to the membership. It was moved by Dr. S. Orvig and seconded by Dr. R.H. Douglas that they be adopted, carried.

The Annual Report of the Executive Committee for 1959-60 was submitted to the meeting. This report had been printed and circulated to the Branch membership. It was moved by Mr. M. Kwizak and seconded by Mr. J.M. Leaver that the report be adopted, carried

It was moved by Mr. H.M. Hutchon that the Canadian Branch fees for 1961 be set at the same figures as in 1960 and that arrangements with regard to remittances to the Parent Society remain unchanged, seconded by Mr. R. Anderson and carried.

The President referred to a letter from the Toronto Centre commenting on a publication date in the Report of the Prize Committee. This was commended to the attention of the incoming executive committee.

It was moved by Mr. H.M. Hutchon that Mr. A. High be the Auditor for 1961, seconded by Mr. D.E. Page and carried. A vote of thanks was tendered to Mr. High for his services to the Branch in 1960.

In his closing remarks the retiring President reviewed the activities of the year. A highlight is the planned Branch meeting with the Learned Societies on June 7th and 8th at Queen's University, Kingston. The President's visit and talk to each of the Centres this year is recommended as a Branch tradition. A Canadian meteorological journal remains a live issue.

Report from the President

Following the successful meeting held in Kingston last year with the Canadian learned societies, the Canadian Branch, Royal Meteorological Society will hold similar meetings in Montreal this year on 6 and 7 June. An interesting program is planned and we hope that every member who can possibly do so will attend at least some of the sessions.

A committee on "the organization and future" of the Canadian Branch has been established.

Investigation and study continued during the year respecting a Canadian meteorological publication. Progress was slow, but all possibilities have not yet been exhausted. Professor J.S. Marshall was appointed to the Editorial Board of the Quarterly Journal of the Royal Meteorological Society. The similar appointment of a Canadian member to the Editorial Board of Weather is being explored. As a result of representations from the Darton Company, the terms of reference of the Darton Prizes will probably be changed. Official confirmation of these changes is expected shortly.

The amount remitted to the Royal Meteorological Society, London, includes their portion of the fees for both 1959 and 1960. The increase in ordinary expenditures has been mainly due to the costs of publishing the various Canadian Branch documents. This increase has been partly offset by lowered postage and stationery costs brought about by the transfer to the Royal Meteorological Society, London, of responsibility for mailing the Quarterly Journal, and Weather, together with an increase in value of the bonds.

Although the sterling rate of exchange has increased in recent months, revenues and expenditures are approximately equal under the present structure of fees. In view of this, I do not propose to recommend an increase in the annual fees.

I have studied the account of the Canadian Branch of the Royal Meteorological Society, and am satisfied that the Treasurer's Report presents a proper statement of the Branch's financial status as of 31 December 1960.

REPORT OF THE PRIZE COMMITTEE - 1960

The President's Prize Committee met on 3 Feb 61 for the 1. purpose of selecting the winners of the President's Prize and Darton Prize for 1960 and of making recommendations concerning the selection of prize winners in future years.

The committee consisted of D.E. McClellan and A.G. MacVicar.

2. The Committee considered all papers by Canadian Branch members published in a recognized journal bearing the date of the preceding calendar year and previously presented to a Canadian Branch or Centre Meeting to be eligible for the President's Prize.

The Committee considered all papers by Canadian Branch 3. members published in a Royal Meteorological Society publication bearing the date of the preceding calendar year to be eligible for the Darton Prize(s).

4. The Committee reviewed the correspondence between the Canadian Branch Executive, the Weather Committee of the Parent Body of the Royal Meteorological Society, and Darton and Company. It was decided that the 1st and 2nd Darton Prizes would be telescoped into a single category entitled "The Darton Prize".

The Committee agreed to recommend that the President's 5. Prize, 1960, be awarded to Prof. F.K. Hare for his paper "The Disturbed Circulation of the Arctic Stratosphere" published in the Journal of Meteorology, 1960, Vol. 17, No. 1 and presented by him at the Montreal Centre of the Canadian Branch in November 1960.

The Committee agreed to recommend that the Darton Prize 6. 1960 be awarded to W.L. Godson for his paper "Total Ozone and the Middle Stratosphere over Arctic and Sub-Arctic areas in Winter and Spring" published in the Quarterly Journal of the Royal Meteorological Society, 1960, Vol. 86, No. 369.

The Committee made recommendations concerning the awarding 7. of prizes. These are contained in an attachment to this report.

The lists of papers which were considered eligible for the 8. prizes is attached.

RECOMMENDATIONS REGARDING SELECTIONS AND AWARDING OF PRIZES BY THE CANADIAN BRANCH

1. INTRODUCTION

The precedent concerning the awarding of the President's Prize has become well established. No major modification should be made concerning this award.

The changes suggested by the Parent Society and the Canadian Branch Executive involved the telescoping of the first and second Darton prizes. This suggestion met with the unanimous approval of the Committee.

It was noted that there is an increasing tendency for awards to be made to members of the Society who are engaged primarily in research endeavor. The gap in scope and depth of background shown in papers written by the "research" group as compared to papers written by the "operational and administrative" group was clearly evident. It was felt that the Canadian Branch should encourage papers written by members who are not engaged primarily in research activities. The problem could be resolved by the addition of a new prize which would be restricted to members who are primarily engaged in operational and administrative duties.

It was apparent that in some years many papers were eligible for the Society's award, while in other years only a few papers were eligible. If the eligible period is extended to two years, it was felt that greater freedom would be given to the Prize Committee in making their selections.

At present, the Prize Committee shoulders the entire responsibility for ensuring that all eligible papers are considered for awards. Revised administrative procedures to broaden this responsibility load should be devised.

2. The Committee recommends that all papers by Canadian Branch members published in a recognized journal in the preceding two calendar years and previously presented to a Canadian Branch or Centre meeting and which have not previously been awarded a prize by the Canadian Branch, shall be eligible for the President's Prize. This prize shall be considered the senior prize awarded by the Canadian Branch of the Royal Meteorological Society. 3. The Committee recommends that all papers published by Canadian Branch members published in a Royal Meteorological Society publication in the preceding two calendar years and not previously awarded a prize by the Canadian Branch, shall be eligible for the Darton Prize.

4. The Committee recommends that all technical and sub-technical papers by Canadian Branch members, whose routine duties are primarily outside the research field, published in a recognized journal or in a publication of the Meteorological Branch, in the preceding two calendar years and which have not previously been awarded a prize by the Canadian Branch, shall be eligible for the NEW Prize.

5. The Committee recommends that as an aid to the establishment of the eligibility lists, each Centre should be required to send to the President of the Branch by February 1st each year, a list of papers by their Canadian Branch members published in a journal bearing the date of the previous calendar year. A list of speakers and topics at each Centre meeting during the previous year should also be forwarded to the President.
