- c. The point was made that the CMOS nationally is changing direction quite dramatically. It was suggested that the Ottawa Centre Executive should have a special meeting at the Rimouski Congress, perhaps over lunch or after sessions one day to discuss, once direction was clear.

Ann McMillan met with Ottawa Tourism and they will put together a portfolio of proposals from venues for us to consider once we confirm with them that 2019 is a "go".
